  - ii. Perhaps council should be approached regarding an increase of the Library Budget considering so many numbers are out of the Library's control. Revenue lines are going to take time to recover. CEO will trim the budget as much as possible without cutting services or materials. Ask council to let us know what we should cut. An argument can be made regarding how much of the budget is beyond the control of the CEO and the Board utilities, gas and insurance. Hours should not be cut as the library will not meet the needs of the community. CEO should aim for a 4% increase. Donations line may be too low. Patron numbers will come back. Insurance will increase 20-30% this year. The plan to go fine-free for 2022 will be tabled at this time. Budget meeting will take place on Tuesday, November 9, 2021 @ 3:30 p.m. in the Shaw Room.
