WHEREAS the mambers of the Fort Frances
Library Association have requested the Council of
the Town of Fort Frances to establish the Public
Library, under the Public Library Act, being Chapter 80,
-9-, Edward VII, Statutes of Ontario.

AND WHEREAS it is necessary that a Bylaw for that purpose receive the assent of the Majirity of the Electors voting thereon.

BE IT THEREFORE ENACTED, and it is hereby enacted, by the Municipal Council of the Town of Fort Frances, as follows;-

- 1. That a Public Library be established in the Town of Fort Frances.
- 2. That the Library, assets and Property of the Fort Frances Library Association be transferred to a Board to be appointed in accordance with the provisions of the Public Library Act, being Chapter 80,-9, Edward VII, Statutes of Ontario, and that the said Library be established as a Public Library.
- 3. That the Votes of the Electors, be taken on this Bylaw, at the same time and at the same places as the Annual Election of Municipal Councillors for the year 1914.
- office in the Town Hall, at 12 o'clock noon, the Mayor shall appoint in writing signed by him, two persons to attend at the final summing up of the votes, by the Clerk, and one person to attend at each Polling Place on behalf of the persons desirous of promoting, and a like number on behalf of the persons desirous of opposing the passing of this Bylaw.
